TERMS AND CONDITIONS OF ENTRY

- > The artwork(s) entered in 'The Emerging International Indigenous Artist of the Year Award 2024' (the EIIAYA) must be an original work, created in any visual art medium, and owned by the submitting artist.
- > Works must have been completed within the 2024 calendar year.
- > There is a maximum of three (3) entries per artist.
- > If any of the entries are portraiture, the artist is responsible for obtaining the consent of the sitter/subject of the portrait for the artwork to be included in the EIIAYA 2024. Without the sitter's signed consent (in the 'Portraiture' section of the entry form), the artwork will be ineligible for judging.
- > The non-refundable entry fee is AUD\$125 per artist.
- > Judging will happen in two stages by our panel of judges. Judges will select finalists via the images submitted, and choose the award winner from the finalists. The judges decision in selecting the finalists and the winner will be final, and no correspondence will be entered into.
- > Entries close at 5.00pm/17:00 Australian Central Standard Time (ACST) on Monday 18 November 2024.
- > No responsibility is accepted for late or misdirected entries.

HOW TO ENTER

- > Entrants must complete the entry form and pay the non-refundable entry fee by direct deposit or credit card.
- > Digital images of each artwork submitted must be .jpg format of a resolution of no less than 300dpi. The file naming protocol is: Artist's first name_Artist's family name_Title of artwork_Medium.
- > Completed entry forms together with digital images (jpgs) of the artwork(s) via email to theindigenousartbook@gmail.com.
- > An entry into TEIIAYA will not be verified until the completed entry form, images and entry fee are received and receipted by the TIAB.
- > TIAB will not accept any changes to the details of the entry once the entry form is submitted.

- > Finalists selected for the TEIIAYA will be showcased on a dedicated EIIAYA website.
- > Voting for 'The People's Choice Award 2024' will be submitted via the EIIAYA website.
- > At the artists' discretion, artworks may be made available for sale. The IAB will connect potential buyers with artists to finalise purchasing arrangements. No commission will be payable on any artwork sold.
